Also Lawrie Yearsly (BB racing), Gloria Drake (WB sailing school)

-would like to address the issue of milfoil growth and how it’s been affecting the racing and sailing in WBL in the past couple years.

-Has become cumbersome and some are not racing because of it.

-Differences in approach from WBLCD consultant.

-realizes the Board has been busy struggling with dock issues.

-Key area is missed in study – north of peninsula (see maps)

-Question is what is acceptable level of nuisance? It is impairing recreational boating.

-WBYC & Black Bear Racing want to work together on this problem

Q&A w/ Board

Michaud – ongoing struggle with aquatic vegetation. Board decided it would concern itself with the navigable water area. Low water levels are spiking growth and creating issue now

Steve McComas, Blue Water Science

-Milfoil has been in lake for 20 yrs now. How can we work together to benefit the lake.

- With high water, plants were still 2 – 3 feet below surface. Last year there were spots where plants were closer to surface. We had large number of native weeds growing up, mixed with a little milfoil. If you treat milfoil in these areas, the other plants would still be up and impact boats. Stronger herbicide produces longer term ecological effects.

Steinworth – have you seen mats of milfoil with nothing else?

Steve – only in parts of the marsh

Janet Calahan, resident

When the plant is cut, does it regenerate quickly?

Michaud – nature of WBL contains it in certain areas due to bottom composition. Similar conditions as in early '90s. Everything green is not milfoil. Nearly all other plants are good and are best defense against milfoil spread. Treated with 24d in early 90s had some problems & more damage than wanted. Areas of dead zones. The following year milfoil spread in areas. Harvesting may be good choice if goal is keeping plants down for recreational use. Dynamic natural system, let lake be lake.

Driscoll – There is a grant available thru the MN DNR.

Michaud – refer to lake quality committee for action

Parenteau – LQC will look at possibilities. Steve McComas will be back in April to do presentation on the Aquatic Plant Survey.

6c. EAW resolution. Docks of White Bear has requested an EAW for possible expansion of docking. WBLCD is LGU (Local Government Unit)

Alan – Resolution recognizes WBLCD as the LGU and by authorizing this means they put info in, we check for completeness, any copying or publishing costs will be covered by requestor.
