Lake Education Committee (LEC): This committee provides public education, with additional duties that may be assigned by the Board.

Lake Quality Committee (LQC): This committee manages aquatic invasive species (AIS), such as milfoil; tests and reports on water quality; selects and supervises consulting engineering services; oversees ecological impact of activities on the lake, with additional duties that may be assigned by the Board.

Lake Utilization Committee (LUC): This committee reviews dock licenses, lake usage permits, and ordinances; places and removes navigational buoys; communicates with law enforcement and public safety; maintains and enhances the recreational element of lake, with additional duties that may be assigned by the Board.
