Altstatt – meeting was held with Alan, Pat, Gene, Jane, Bryan and some local legislators again regarding the joint powers and responsibilities. Would like to have task force set up from board to more easily meet and move forward.

Harper – several ways this could go. They want to know what we need to move forward with a possible project. What does it take to form a joint powers board. Facilitator? RFP? Would legislative authority changes be needed for WBLCD role?

St Germain – are we qualified to do this?

Kantrud – beginning of the process, smaller group could go forward. Legislators thought this would be appropriate group to move forward

8b3. Water level 921.09. Last year on this date lake was still frozen. In 2013 920.30. last year 920.57 so now is 6” higher than last year this time.
